Pursuant to the provisions of Section 92(1) of the Public Service Commission Act, 2017, we wish to draw your attention on the gazettement of the *Public Service Commission (Performance Management) Regulations*, 2021 which came into force on 4<sup>th</sup> August, 2021. The said regulations have also been uploaded on the Commission's website.

Consequently and arising from the restrictions of the Covid-19 pandemic and containment guidelines issued by the Ministry of Health, the Commission intends to mount a half-day sector-based virtual webinar to sensitize all Ministries, State Departments, Agencies and Public Universities under the purview of the Commission to ensure familiarity and uniformity in the implementation of the said regulations.
