## INVITATION TO PARTICIPATE IN THE 2021 FINANCIAL REPORTING (FIRE) AWARD


The Financial Reporting Excellence (FiRe) Award is a joint initiative of the Institute of Certified Public Accountants of Kenya (ICPAK), Capital Markets Authority (CMA), Nairobi Securities Exchange (NSE), Public Sector Accounting Standards Board (PSASB) and Retirement Benefits Authority (RBA); jointly referred to as **Promoters**. The award seeks to promote and recognize excellence in financial reporting, sound governance practices and environmental reporting by both private and public entities domiciled in the East African region.

PSASB joined the Award in 2014 and made participation by public entities mandatory in bid to encourage organizations to embrace best practice in reporting and demonstrate good governance. Participation in the Award has resulted improved financial reports and disclosures through formal feedback from the evaluation panel.
